

PRESER ACE SUPPOSITORIES T

- ◆ PRESER ACE SUPPOSITORIES T contains such active ingredients to relieve piles with annoying pain/acute bleeding as lidocaine that relieves pain, tetrahydrozoline hydrochloride that inhibits bleeding, and hydrocortisone acetate that relieves inflammation, and achieves an excellent effect.
- ◆ It soothes symptoms, and gives comfortable sense of use.

Indication

To alleviate pain/bleeding/swelling/itching due to bleeding piles/blind piles

Dosage and administration

Insert the following dose into the anus.

15 years or over: 1 piece per dose, 1 to 3 times daily

Under 15 years: Do not use

★ Take a bath or wash the affected site with warm water before use. The effect is even better if the drug is used after defecation in the morning and before bed time in the evening.

Precaution

- Comply with the prescribed dosage and administration instructions.
- If the drug gets soft, cool it for a while before use. If the drug is too hard, wait until it gets soft enough.
- Use the drug only for the anus.

Ingredient

In 1 piece (1.65g)

Hydrocortisone acetate 5mg

Tetrahydrozoline hydrochloride 1mg

Lidocaine 60mg

l-Menthol 10mg

Allantoin 20mg

Tocopherol acetate 60mg

Chlorhexidine Hydrochloride 5mg

Excipients

Carboxyvinyl polymer, anhydrous silicic acid, glycerin stearate, hard fat

Precautions

When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions are more likely to occur)

- This product should not be used in the following persons
 - Persons who have had an allergic symptom to the drug or the drug ingredient, namely, chlorhexidine.
 - Patients with purulent hemorrhoidal lesions.
- Do not take this medicine for a long time

Consultation

- The following persons should contact a physician, pharmacist, or registered salesperson for a consultation before use
 - Patients undergoing medical treatment from a physician.
 - Pregnant women or women suspected of being pregnant.
 - Patients who have experienced allergic symptoms associated with drugs, etc.
- If the following symptoms are observed after using this drug, these may be adverse reactions, so immediately discontinue the use, and show this document to your physician, pharmacist, or registered sales person for a consultation
 - Skin: rash/redness, itching, swelling
 - Other: irritation, purulence
- The following serious symptoms may occur in rare cases. In such cases, immediately seek medical aid.

Shock (anaphylaxis): symptoms, such as itching of skin, urticaria, hoarseness, sneezing, itchy throat, breathing difficulties, palpitations, and clouding of consciousness may occur immediately after use.

- If the symptoms do not resolve after taking this drug for about 10 days, stop taking this medicine, and show this document to your physician, pharmacist, or registered salesperson for a consultation

Precautions for storage and handling

- Avoid direct sunlight, and store in a cool place with little humidity and temperature below 30°C.
- Store the product beyond the reach of children.
- Store the suppositories in the outer box with their tips downward, and place as indicated on the outer box.
- Do not transfer the drug to other containers. (It may lead to misuse or quality deterioration)
- Do not use the product past the expiration date. Even within the expiration date, try to use it up as soon as possible once it is opened. (to assure the quality)
