◆PRESER ACE OINTMENT contains active ingredients to relieve piles with annoying pain/acute bleeding such as lidocaine that relieves pain, tetrahydrozoline hydrochloride that inhibits bleeding, and hydrocortisone acetate that relieves inflammation, and achieves an excellent effect. ■It soothes symptoms, and gives comfortable sense of use.

Indication

[Application] To alleviate pain/bleeding/swelling/itching due to bleeding piles/blind piles and for disinfection

Dosage and administration

Apply an appropriate dose onto the anus once to 3 times daily.
Take a bath or wash the affected site with warm water before use. The effect is even better if the drug is used after defecation in the morning and before bed time in the evening.
Comply with the prescribed dosage and administration instructions.
When allowing children to use the medicine, a guardian must be present to watch and tell such them how to use it.
Use the drug only for the anus.

ingredient and amount

In 100 g
Hydrocortisone acetate 0.5g
Tetrahydrozoline hydrochloride 0.05g
Lidocaine 3g
Chlorpheniramine Maleate 0.2g
l-Menthol 0.2g
Allantoin 1g
Tocopherol Acetate 3g
Chlorhexidine Hydrochloride 0.25g

Excipients

BHT,Dimethylpolysiloxane ,Carboxyvinyl polymer,Palmitic acid dextrin,synthesis Squalane,Medium-chain fatty acid triglyceride,Petrolatum

Precautions

When not to use the product

(If you do not follow these instructions, the current symptoms may worsen or adverse reactions are more likely to occur.)

●This product should not be used in the following persons:

Persons who have had an allergic symptom to the drug or the drug ingredient, namely, chlorhexidine.

Patients with purulent hemorrhoidal lesions.

● Do not take this medicine for a long time

Consultation

●The following persons should contact a physician, pharmacist, or registered salesperson for a consultation before use.

Patients undergoing medical treatment from a physician

Pregnant women or women suspected of being pregnant.

Patients who have experienced allergic symptoms associated with drugs, etc.

If the following symptoms are observed after taking this drug, these may be adverse reactions, so immediately discontinue the use of this drug, and show this document to your physician, pharmacist, or registered salesperson for a consultation.

The following serious symptoms may occur in rare cases. In such cases, immediately seek medical aid from a physician.

Shock (anaphylaxis): Symptoms, such as itching of skin, urticaria, hoarseness, sneezing, itchy throat, breathing difficulties, palpitations, and clouding of consciousness may occur immediately after use.

If the symptoms do not resolve after taking this drug for about 10 days, stop taking this medicine, and show this document to your physician, pharmacist, or registered salesperson for a consultation.

Precautions for storage and handling

Avoid direct sunlight, and store the product in a cool place with an air tight closure on.
Store the product beyond the reach of children.
Do not transfer the drug to other containers. (It may lead to misuse or quality deterioration)
Do not use the product past the expiration date.
Even within the expiration date, use up as soon as possible once it is opened (to assure the quality).
